

Welcome to the web site (the "Site") of Mesa Market Place Swap Meet ("Mesa Market Place Swap Meet", "we", "us" and/or "our"). #### Information We Collect

##### Aggregated Personal Data

In an ongoing effort to better understand and serve the users of the Mesa Market Place Swap Meet Services, Mesa Market Place Swap Meet often conducts research on its customer demographics, interests and behavior based on the Personal Data and other information provided to us. This research may be compiled and analyzed on an aggregate basis, and Mesa Market Place Swap Meet may share this aggregate data with its affiliates, agents and business partners. This aggregate information does not identify you personally. Mesa Market Place Swap Meet may also disclose aggregated user statistics in order to describe our services to current and prospective business partners, and to other third parties for other lawful purposes. We will keep any information that you provide to us until such time as you delete your account with the Mesa Market Place Swap Meet Service.

#### Our Use of Your Personal Data and Other Information

Mesa Market Place Swap Meet will not sell or rent to any third party any of the personal information or data that you provide to us. Mesa Market Place Swap Meet uses the Personal Data you provide in a manner that is consistent with this Privacy Policy. If you provide Personal Data for a certain reason, we may use the Personal Data in connection with the reason for which it was provided. For instance, if you contact us by email, we will use the Personal Data you provide to answer your question or resolve your problem. Also, if you provide Personal Data in order to obtain access to the Mesa Market Place Swap Meet Services such as our newsletters, we will use your Personal Data to provide you with access to such services and to monitor your use of such services.

Market Place Swap Meet and its affiliates (the "Mesa Market Place Swap Meet Related Companies") may also use your Personal Data and other personally non-identifiable information collected through the Services to help us improve the content and functionality of the Services, to better understand our users and to improve the Mesa Market Place Swap Meet Services.

Mesa Market Place Swap Meet and its affiliates may use this information to contact you in the future to tell you about services we believe will be of interest to you. #### Our Disclosure of Your Personal Data and Other Information

Mesa Market Place Swap Meet is not in the business of selling your information. We consider this information to be a vital part of our relationship with you. There are, however, certain circumstances in which we may share your Personal Data with certain third parties without further notice to you, as set forth below:

#### Business Transfers

As we develop our business, we might sell or buy businesses or assets. In the event of a corporate sale, merger, reorganization, dissolution or similar event, Personal Data may be part of the transferred assets. Related Companies: We may also share your Personal Data with our Related Companies for purposes consistent with this Privacy Policy. Agents, Consultants and Related Third Parties: Mesa Market Place Swap Meet, like many businesses, sometimes hires other companies to perform certain business-related functions. Examples of such functions include mailing information, and maintaining databases. When we employ another company to perform a function of this nature, we only provide them with the information that they need to perform their specific function.

#### Legal Requirements

Mesa Market Place Swap Meet may disclose your Personal Data if required to do so by law or in the good faith belief that such action is necessary to (i) comply with a legal obligation, (ii) protect and defend the rights or property of Mesa Market Place Swap Meet, (iii) act in urgent circumstances to protect the personal safety of users of the Services or the public, or (iv) protect against legal liability.

#### Exclusions

This Privacy Policy does not apply to any Personal Data collected by Mesa Market Place Swap Meet other than Personal Data collected through the Services. This Privacy Policy shall not apply to any unsolicited information you provide to Mesa Market Place Swap Meet through the Services or through any other means. This includes, but is not limited to, information posted to any public areas of the Services, such as bulletin boards (collectively, "Public Areas"), any ideas for new products or modifications to existing products, and other unsolicited submissions (collectively, "Unsolicited

Information"). All Unsolicited Information shall be deemed to be non-confidential and Mesa Market Place Swap Meet shall be free to reproduce, use, disclose, and distribute such Unsolicited Information to others without limitation or attribution.

#### Children

Mesa Market Place Swap Meet does not knowingly collect Personal Data from children under the age of 13. If you are under the age of 13, please do not submit any Personal Data through the Services. We encourage parents and legal guardians to monitor their children's Internet usage and to help enforce our Privacy Policy by instructing their children never to provide Personal Data on the Services without their permission.
